THE HURN NEIGHBOURHOOD PLAN

The very good news is that the Hurn Neighbourhood Plan has now been adopted by BCP Council. Finally, after more than 4 years of hard work from Hurn residents and Parish Cllrs in putting this Plan together, and a local referendum, it is now part of the statutory development plan for the area. This statutory status will give the Hurn Neighbourhood Plan weight in the BCP planning process and its policies must be taken into account, alongside the current Christchurch Local Plan, when planning decisions are made in Hurn Parish.
