PROPOSED HURN COURT FARM QUARRY EXTENSION DROP IN EVENTS

**New Milton Sand and Ballast propose to extend operations in Hurn
to the field alongside the Airport**

The Parish Council believe that these drop ins will be of interest to residents, and we specifically requested New Milton Sand and Ballast (NMSB) to involve the community and discuss their plans. This is your opportunity to find out what is proposed and give your views. These events are being held in advance of submission of a planning application to BCP Council, so please do attend on either day, ask any questions, and have your say to NMSB.

NMSB, the long-standing quarry operator in Hurn, proposes to extend its mineral extraction operations at Hurn Court Farm, which are currently located opposite the airport.

This proposed extension, representing the final phase of extraction at this site, involves changing the use of adjacent grazing land, between the Airport and Hurn Bridge Farm, to allow for further temporary extraction of minerals.

To encourage community participation, NMSB is inviting Parish residents to a drop-in session to learn more about the proposed plans and provide feedback. If you can't attend in person and would like to speak to anyone from the company, you can email community@nmsb.co.uk.

CAN YOU HELP US SOLVE THIS MYSTERY?

The Parish Council received an enquiry asking if we knew the location of Pardy's Hill in Hurn. We have never heard of this location and the only Pardy's Hill anyone seems to know about is in Corfe Mullen.

However, we have been given the following evidence and wonder if anyone can throw any light on the mystery. Do you know the people mentioned or have any information about Pardy's Hill, Hurn? Maybe it was renamed?

We have a copy of a birth certificate from 1955 which shows the father as U. Brewer of 19 Pardy's Hill, Hurn. He is noted as an Aircraft Fitter. The child is Paul Brewer.

We have also been given 2 separate newspaper clippings both relating to traffic accidents, but unfortunately undated. One refers to Vernon Seddon of 43 Pardy's Hill, Hurn and the other to Doreen Hayden of 2 Pardy's Hill, Hurn.

It seems strange that we have 3 individual documents, one being an official birth certificate, which give the Pardy's Hill address in Hurn, but can find no record of this location.

ECO COMPOSTING APPLY TO INCREASE INCINERATION CAPACITY

In December 2022 Eco Composting at Chapel Lane, Hurn, was granted planning permission for an Energy Recovery Incinerator, despite over 700 objections logged on to the BCP Council planning portal. The Incinerator, not yet constructed, will burn household waste brought into the site by trucks, with the Incinerator needing to be fed 24/7. A condition of the grant was that they could not burn more than 60,000 tonnes of waste per annum. Under a new Planning Application No. 8/24/0828/CONDR, they are now applying to amend that condition to increase the capacity to burn 105,000 tonnes per annum. This will mean more trucks entering/exiting the site and additional emissions from the chimney stack. If this application is of interest you can comment on the BCP Council website:
